Notice of Fees for the 2022/2023 Season

The Club Committee shall determine:

- a. the membership fee(s) and any other fees payable by each Member;
- b. the due date for the fee(s); and



c. the manner of payment for the fee(s).

As per meeting 2 August, the committee has made the decision that, for the 2023/2024 season, the fees should remain at:

- Family Membership \$55 (Need to state individual family member's names)
- Individual Membership \$30
- Life Members No fee

A conversation ensued to discuss whether fees should be paid at all. Several points were agreed to:

- 1. We will continue to pay membership fees "to feel like we are part of something" and so we are "accountable" to the club.
- 2. If fees are not able to be paid by an individual or family due to financial reasons, the club will consider meeting their fees or costs of participation in events on a case-by-case basis.
- 3. Fees should go towards maintenance of sport equipment and encourage participation in sport events by offsetting the cost of entry fees.
- 4. Given the low fees, volunteer lifeguards are not exempt from paying the membership fees.
