Statement of Service Performance

The Warrington Surf Lifesaving Club Incorporated For the year ended 31 May 2023 Cash Basis

'What did we do?', 'When did we do it?'

Purpose

The Mission of the Warrington Surf Life Saving Club ("WSLSC" or " the Club") is to prevent drowning and injury at Warrington Beach. The outcome of the WSLSC activities is the improvement of knowledge of skills in surf survival of community members, provision of a patrolled area to enable beach visitors to "swim between the flags" and to provide and maintain essential rescue equipment accessible to marine search and rescue teams operating on the coast north of Dunedin.

Commentary

Volunteer hours have seen an increase from last season, with a similar number of lifeguards refreshed and patrolling the beach. 19 of our lifeguards qualified or refreshed their first aid awards, with a number of these stepping up to a higher level of qualification this year, the club now has another 5 advanced first aid qualifications within the membership. A further 3 lifeguards now hold their IRB drivers award, and for the first time, we have a qualified Rescue Water Craft (RWC) operator in the club. 3 people needed to be assisted to safety over the season, and 5 minor first-aid incidents occurred. Adding to this are the 2,664 members of the public who were involved in preventative actions, which builds out the picture of our role in the community over the past season. It is great to see incident numbers remain low, with a large number of people interacted with to encourage safer behaviour before they get to the point of needing assistance.

Sport

WSLSC had a fantastic year of sport, with the team winning two medals in Junior Sport Nationals (Oceans '23), 5 medals at Master's Nationals, and 5 medals in Senior Nationals. Senior Nationals in particular was a big wave competition with Warrington teams showing tenacity and drive to bring home those medals. A special mention goes to the canoe team for winning medals in all but one race that they entered, fantastic results!

Youth Education

Our number of junior members has continued to grow this season, and the dedicated lifeguards who run the nippers programme have continued to enhance the opportunities available to them. It was great to see some rookie lifeguard training taking place, and the nippers are excited to progress their lifeguarding skills and subsequent beach safety knowledge.

Special Project

The Club have been working with Dune Intelligence Ltd. to provide a rip map this season. The rip map shows where there is a chance of rips being present on the coastline and is formed using a drone to capture aerial images. The map then shows a line of bubbles representing where aerial images were taken. These dots are colour coded to show the most likely locations of rips when the photos were taken.

Statement of Accounting Policies

The Warrington Surf Lifesaving Club Incorporated For the year ended 31 May 2023

'How did we do our accounting?'

Basis of Preparation

The entity has elected to apply PBE SFR-A (NFP) Public Benefit Entity Simple Format Reporting - Accrual (Not-For-Profit) on the basis that it does not have public accountability and has total annual expenses equal to or less than \$2,000,000. All transactions in the Performance Report are reported using the accrual basis of accounting. The Performance Report is prepared under the assumption that the entity will continue to operate in the foreseeable future. The basis of the accounting is historic cost save for the A Frame building which has been revalued some years ago.

Goods and Services Tax (GST)

The entity is registered for GST. All amounts are stated exclusive of goods and services tax (GST) except for accounts payable and accounts receivable which are stated inclusive of GST.

Income Tax

The Warrington Surf Lifesaving Club Inc is wholly exempt from New Zealand income tax having fully complied with all statutory conditions for these exemptions.

Bank Accounts and Cash

Bank accounts and cash in the Statement of Cash Flows comprise cash balances and bank balances (including short term deposits) with original maturities of 90 days or less.

Changes in Accounting Policies

There have been no changes in accounting policies. Policies have been applied on a consistent basis with those of the previous reporting period.

We have reviewed the Financial Statements of The Warrington Surf Life Saving Club Incorporated ("the organisation"), which provide information about the past financial performance of the organisation for the year ended 31 May 2023, the statement of financial position and statement of cash flows as at the 31 May 2023, the accounting policies and accompanying notes to the financial statements.

We have conducted our review in accordance with generally accepted review engagement standards in New Zealand (ISRE (NZ) 2400). We performed our review so as to obtain all the information and explanations that we considered necessary in order to provide us with sufficient evidence to give reasonable assurance that the financial statements are free from material misstatements.

In common with other organisations of a similar nature, control over the revenues from donations, membership dues and food and beverage sales paid in cash prior to being banked is limited.

Conclusion

Based on our review, save for the qualification mentioned above, we are satisfied the financial statements give a true and fair view of the financial position of The Warrington Surf Life Saving Club Incorporated as at the 31 May 2023 and the financial performance for the year ended 31 May 2023.
